- On, 18th August, 2017, the Company had completed the dispatch of Postal Ballot forms along with postage prepaid reply envelope to its Members, whose name(s) appeared on the Register of Members/List of beneficiaries as on 11th August, 2017 and also published Newspaper Advertisement in Free Press Gujarat (English) and Lokmitra (Gujarati) edition dated August 19, 2017 declaring 11th August, 2017 as cutoff date for the purpose of voting rights for postal ballot.
- 1.2 The e-voting commenced from Monday 21<sup>st</sup> August 2017, 9:00 a.m. and ended on Tuesday 19<sup>th</sup> September, 2017 upto 5:00 p.m.
- 1.3 Particulars of all the postal ballot forms received from the Shareholders have been entered in a register separately maintained for the purpose in electronic mode.



- 1.4 I have downloaded the data of e-voting from the E- Voting website of Central Depository Services (India) Limited (<a href="https://www.evotingindia.com/">https://www.evotingindia.com/</a>) after the E-voting module was disabled by the Central Depository Services India Limited (CDSL) on 19th September, 2017 at 5:27 P.M.
- 1.5 The Postal Ballot forms were kept under my safe custody in sealed and tamper proof ballot boxes before commencing the scrutiny of such postal ballot forms.
- 1.6 The votes were unblocked on 19<sup>th</sup> September, 2017 after 05:00 p.m. in the in presence of two witnesses namely Ms. Madhavi Gajjar & Ms. Himani Upadhyay who are not in the employment of the company.

They have signed below in confirmation of the votes being unblocked in their presence.

- 1.7 The postal ballot forms were duly opened in my presence and scrutinized and the shareholding was matched/confirmed with the Register of Members of the Company/ list of beneficiaries as on 11th August, 2017. (Cut off Date)

- 1.9 All the postal ballot Forms, received up to the close working hours on 19th September, 2017 the last date and time fixed by the Company for receipt of the forms, were considered for my scrutiny.
