## Ahmedabad: Neighbours cry havoc over ex-soldier's unleashed dog



**AHMEDABAD:** In Shakespeare's Julius Caesar, Mark Antony rouses people to attack Caesar's assassins saying, "Cry havoc and let slip the dogs of war." In Thaltej, as many as seven neighbours of a retired soldier allegedly began warring with him because his pet dog slipped from his grasp.

Bhupal Chauhan, 50, retired from the Army as a junior commissioned officer (JCO) twenty years ago. On Thursday, he filed a complaint with Vastrapur police, alleging that seven members of his residential society, Manibhadra Apartments on Gulab Tower Road, assaulted him.

Chauhan lives in the society with his wife and two children. In his FIR, Chauhan said that on August 22 he was holding his pet dog to take it out for a walk and

also abused and assaulted him. Chauhan stated in his FIR. Chauhan said one of the residents attacked his wife and son. He then called the police control room. He and the other residents were later taken to Vastrapur police station.

Inspector J K Dangar of Vastrapur police said they

feed the stray dogs outside his housing society, as he usually does. "As I was taking my dog outside, some children who were scared of my dog began screaming and running away. This caused my dog to jump away from me and run after the children. I ran behind my dog and managed to get a hold on him," said Chauhan.

Chauhan then went outside the society, fed the stray dogs and returned home.

As he was returning, two society residents - Ghanashyam Dobaria and Umesh Bhavsar - yelled at him for unleashing his dog within the society premises.

Chauhan said two other residents - Ketan and Pinky Thakkar - rushed to him and began assaulting him. Three other residents, Himanshu Patel, Tushar Bhavsar and Chetan Sheth,

## Adani shares fall 2.5% after new report

Nine out of 10 shares of the company were down 2.5% by 12 noon after another foreign report on Adani Group came out on Thursday. The Organized Crime and Corruption Reporting Project (OCCRP) has claimed that Adani Group investors have invested millions of dollars in the market by secretly buying their own shares.

However, the group has denied the allegations. It is said that this is a conspiracy to defame and earn profit. The OCCRP claimed in its report that Adani Group companies had invested crores of rupees in the group's shares through benami investment funds in Mauritius.

Adani Group says we reject these recycling allegations. This new report appears to be an attempt to revive the illegal Hindenburg Report. Adani Group said that the allegations made by OCCRP relate to a case closed a decade ago (10 years).

At that time, the Directorate of Revenue Intelligence (DRI) investigated allegations of over-invoicing, fund transfers abroad, related party transactions and investments by PFIs. In March 2023, the Supreme Court ruled in our favor and closed the case.
