

A case was registered against 05 women for beating a woman by stripping her naked and tying her to a tree in Panchmahal, the trial court rejected the bail application.

Panchmahal. On March 26, a complaint was registered against 06 women accused under sections 323, 354, 354B, 342, 364A, 452, 504, 506(2) of the IPC at Morva Police Station, Panchmahal.

It includes women aged 36 to 71 years. The accused were in judicial custody since March 26. The police filed a charge sheet against the accused in the court. The accused filed a bail application in the

Panchmahal court. 05 women reached the Gujarat High Court, which was rejected. In the case, it was submitted that 06 women entered a woman's house in Bhandoi village of Panchmahal.

He asked the woman to return her daughter. The accused stripped the woman from the house and tied her to a tree. Later he was stoned and stoned. Also threatened to kill. However, the High Court said that the

case is still under investigation. Expressing the court's decision not to grant bail to the accused, the petitioners withdrew the application. The petitioner's lawyer's plea for bail was rejected by the court as the accused was a woman. Now if the circumstances change, the bail will be put again by the applicants. Lo!... Heat to drop by 3 degrees Fishermen advised not to venture into sea for next 5 days

Vadodara, The weather department has predicted the weather in the state of Gujarat for the next five days. According to which, the temperature will drop by two to three degrees in the districts of North and Central Gujarat from today itself. Apart from this, hot humid winds will still blow over the coastal areas for the next two days. Since then, no heat wave or heat alert has been issued in any

district of the state. The atmosphere of the coastal areas will also clear. Hence, there will be no discomfort due to hot humid air. But the meteorological department has instructed the fishermen not to venture into the sea for the next five days. Because, due to sea movement in the Arabian Sea, winds can blow at a speed of 35 to 45 kmph.

Winds will blow at a speed of 25-30 km in Central and

North Gujarat. The Meteorological Department has expressed the possibility of wind blowing in various districts of the state during the next three days, especially in the districts of Central and North Gujarat. The speed of this wind will be 25-30 km per hour and the wind direction will be from west and southwest. Due to this, the temperature of Gujarat will gradually decrease by two to three degrees Celsius. Apart from this, a yellow alert has been declared in the sea for the next five days due to sea movement in the North Eastern Arabian Sea. Hence fishermen have also been instructed not to ply

the sea.
