Relief in tax, other promises made in Congress' manifesto for civic body polls



Ahmedabad : The Congress on Thursday released its manifesto for the upcoming municipal corporation elections scheduled on February 1. Relief in taxes for citizens and other promises have been made in the manifesto. Gujarat Congress chief Amit Chavda while releasing the party's manifesto said every citizen will be given the Gujri Card to get access to the free services offered by the government. He said the BJP that has been in power in the municipal corporations across the state has not bothered to provide basic facilities to people. Despite high taxes, people struggle for infrastructure facilities and water, Chavda said. He said the manifesto is a Congress promise to address the concerns of the people. He hit out at the BJP government for the high taxes and how facilities provided

were not commensurate with the taxes paid. Some highlights of the Congress manifesto A Gujri Card will be given to ensure citizens get access to all the free services offered by the state and centre. Will end the culture of contract and outsourcing in municipal bodies within 24 hours of coming to power. All vacant posts in corporations will be filled. Air emergency services will be provided for accidents and fire emergencies in the municipal corporation limits. Air purifiers will be provided for public roads. Education will be free in municipal schools in English medium. Will reconstruct all potholed roads in all six municipal corporations within a week of coming to power. A relief in taxes for a year for businesses that have been hit by COVID-19. Up to 50% reduction in residential property tax. Will address the issue of stormwater drainage.

Kanu Kalsariya, others given six month imprisonment by Talaja Court; released on bail



Bhavnagar: Socialist activist and former Mahuva BJP MLA Kanubhai Kalsariya and six others have been given six month imprisonment and Rs. 800 fine by a local court in Talaja for illegal entry in Ultra Track cement plant

(trespassing). All seven have been given bail. UltraTrack Cement Limited is the flagship company of Aditya Birla Group. The group had acquired 1,714 hectare land in Talaja and Mahuva talukas of Bhavnagar district between 1999 and 2001 for mining limestone and supplying it to its cement plant in Rajula taluka of neighboring Amreli district. Out of that, around 1,640 hectare was private agricultural land while the remaining was government wasteland. Kalsariya was leading an agitation against mining lease.

HUSBAND DONATES KIDNEY TO WIFE ON VALENTINE'S DAY



Ahmedabad. In year 2017, Mrs. Ritaben Patel - A 43 year old housewife contacted Dr Siddharth Mavani, Consultant Nephrologist and Transplant Physician at Shalby Hospitals, Ahmedabad with complaints of swelling on legs and breathing problem. Investigations suggested that her kidneys were failing. Immediately Kidney Biopsy was carried out and she was diagnosed to have FSGS, a Kidney Filter related problem. In advanced stage, she was managed with medication for 3 years and as she was approaching Kidney Failure stage with multiple complications, her family was counseled for the need of Kidney Transplant which a life is saving procedure for her. Considering Cadaver (Brain Death Donor) may take longer time, her husband Mr. Vinodbhai Patel came forward as a potential Kidney Donor. Both of them were

investigated and found appropriate for Kidney Transplantation. "After USA, India has the world's 2nd largest Live Kidney Transplant program. With the life expectancy of average Indians constantly touching newer landmarks, it has also been putting them at higher risk of Diabetes and High BP. Easy availability of testing labs and over all awareness in doctors and general population has been helping detection of more number of kidney problems across different age groups. According to recent studies in India: 17.5 - 18 % of Indian population is having Chronic Kidney Disease (CKD) and out of them 5 - 6% (for Gujarat: 8.9%) are having serious kidney problems, requiring Renal Replacement Therapy in the form of Dialysis or Kidney Transplant. On a population of having Chronic Kidney Disease (CKD) of 20, 20,000 population of India requiring these therapies and every year > 1 lakh patients are entering in this pool. So we can understand the mammoth nature of this problem. Kidney Transplant is considered as the Gold Standard treatment compared to Dialysis for any patient suffering from CKD," shared Dr. Siddharth Mavani. (19-8)

Ahmedabad : An 80-year-old woman who had been living alone in Vejalpur was found dead in her home. The woman was hit on the head repeatedly by something before she died. Police have registered a case and are

her house and her two sons were living separately. The woman had several other relatives. She lived in Vejalpur to take care of the property.
