**EXPLANATORY STATEMENT AS REQUIRED UNDER SECTION 102 OF THE COMPANIES ACT, 2013.**

In conformity with the provisions of Section 102 of the Companies Act, 2013, the following Explanatory Statement sets out all material facts relating to Special Business mentioned in the accompanying Notice and should be taken as forming part of the Notice.

**Resolution No. 1 - Alteration in Main Object Clause of the Company:**

As you are aware, the Company Disha Resources Limited (Formerly Known as Arihant Avenues and Credit Limited) was originally incorporated on 06<sup>th</sup> March, 1995 with the Main Object as mentioned in the Memorandum of Association of the Company which reflects that the Company is carrying on the business of Real estate and Financing Activity.

The Directors decided to alter the Object clause of the Memorandum by way of addition of trading of waste paper, recycling of paper, trading of textile and logistic services in the current line of business of the company and the same was approved in their meeting held on 24<sup>th</sup> February, 2016. The Shareholders of the company by way of special resolution passed through postal ballot approved the same. The result of which was declared on 28<sup>th</sup> March, 2016.

Further, to move further and achieve the better mark in the society, the Board has proposed to delete the clause No.1 & 2 by replacing of following clause.
